Board of Directors Candidate Information

Purpose:

Greater Yuma Economic Development Corporation is a 501 C-6 not-for-profit organization. The Board shall make all policy statements on behalf of the Corporation and decide such policy issues as they come before the Board, as well as guide the direction and action of the Corporation so as to support the organization's mission and needs as originally conceived and written into the Bylaws of the Corporation.

Length of term:

Three years, up to a maximum of 6 years (two consecutive terms) pending approval of the Board.

Requirements for Serving as a Director of the Board:

1. Attendance requirements – Elected Directors shall attend all regular and special meetings; no more than four (4) absences or three (3) consecutive absences will be allowed in any twelve (12) month period. Failure to comply with this requirement shall constitute “good cause” as a ground for removal under Section 4.7
2. Special Meetings defined – Quarterly Investor luncheons, Annual Investor Dinner, Special Networking Events for visiting dignitaries and meetings with visiting clients.
3. The recruitment and retention of Private Sector Investors – As needed Directors will be required to assist Greater Yuma EDC staff with the recruitment and retention of Private Sector Investors
4. Directors are responsible for the formulation and oversight of policies and procedures of the organization
5. Directors are responsible for the financial condition of the corporation
6. Directors are responsible for the promotion of Greater Yuma EDC

Board Meetings and Time Commitment:

1. The Board of Directors meets at 11:30 a.m. on the 2nd Thursday of every other month.
2. Board members will contribute 3 to 10 hours monthly depending on client activity.
